

PLEASE READ INSTRUCTIONS COMPLETELY BEFORE ASSEMBLING AND USING THIS MOUNT KIT

PARTS

This Bracketron mount kit includes:

- **Device holder** for monitor, tablet, phone, or other device. Device holder may require some preliminary assembly before assembling rest of mount package (if supplied, see instruction sheet for device holder)
- **Pedestal** (round central portion of mount)
- **Base** to attach assembled mount to vehicle
- **Two knuckles** that fit on each end of pedestal. One knuckle joins device holder to pedestal; one knuckle joins pedestal to base. Each knuckle has an adjustment knob. When assembling mount, be sure one end of each knuckle fits into groove at each end of pedestal.

B

ASSEMBLY

To assemble this Bracketron mount kit, the device holder and base must be attached to the two knuckles on either end of the pedestal, and the base must be attached to the vehicle. The assembly steps can be done in whatever order is easiest and most convenient.

- **Attach device holder to pedestal:** Loosen adjustment knob on knuckle at one end of pedestal and insert ball on device holder into socket. Then tighten adjustment knob on knuckle.
- **Attach pedestal to base:** Loosen adjustment knob on knuckle at other end of pedestal and insert ball on base into socket. Then tighten adjustment knob on knuckle.
- **Attach base to vehicle.** Base may be attached to vehicle either before or after other steps of mount assembly.

Once mount is assembled and attached to vehicle, **attach device to device holder** (if supplied, see separate instruction sheet showing how to use device holder).

After device is attached to device holder, **use adjustment knobs** on one or both knuckles to move device into perfect viewing position. Do not overtighten adjustment knobs.
